By registering for the Australian Breathwork Association's (ABA) Breath Australia Conference 2026 (BAC 26), you acknowledge and agree to the following terms:

1. Conference details are correct at the time of publication; however, ABA reserves the right to amend details without prior notice.
2. All pricing listed on the BAC 26 website is in Australian dollars unless otherwise noted.
3. Registration is not considered complete until full payment is received. Payment can be made securely via booking link in Confirmation email, either by bank transfer or Stripe.
4. Upon receipt of your registration, you will receive a confirmation email. Upon receipt of your Ticket payment you will receive confirmation and a tax invoice.
5. If payment is not received, the booking will be deemed invalid.
6. Dietary requirements must be indicated at the time of registration. Catering details are finalised a minimum of 2 weeks before the event. Requests made after this deadline may not be able to be accommodated.
7. All cancellation requests, changes, or name substitutions must be submitted in writing to breathaustraliaconference@gmail.com. Telephone requests will not be accepted. Refer below for cancellation policy and fees.
8. The following cancellation policy applies to all bookings:
 - Cancellations received on or before 31st May 2026 will be refunded in full.
 - Cancellations received between 1st June and 1st July 2026 will be refunded 50% of ticket.
 - No refunds will be available for cancellations made after 1st July 2026.
