To the Quays Committee

On 28 February 2023 I sent the below email and above attachment to the Quays Committee, excluding Christine Mathew for obvious reasons. There has been no response or acknowledgement whatsoever from the Quays Committee to my formal complaint.

There have however been additional emails from Christine Mathew to me - 5 in fact between 21/3 & 23/3/23, regarding the PBC Newsletter of 1 March 2023 and its distribution (or not) to Quays Owners. Even more disturbing is that Christine Mathew sent 8 emails to Sue Doves on the same subject, all on 23/3/23. The emails were received at 1:29am, 8:17am, 8:29am, 9:58am, 10:34am, 10:46am, 12:19pm & 8:19pm. Sue politely answered the first three emails at 8:02am, 8:44am & 8:47am and then desisted, as neither of us was able to comprehend why Christine Mathew would initiate contact with Sue on this subject, let alone with such concerning intensity.

Given the new incident regarding the PBC Newsletter and the Quays PBC Representative, I now include Stansure Strata, the PBC Chair, the PBC Secretary and the PBC BCM in this correspondence, for their information and records.

I reiterate the conclusions made in my original complaint - that Christine Mathew is not a proper person to be on the Quays Committee and certainly should not be its representative on the PBC.
